

BACHELOR OF ARTS IN CRIMINAL JUSTICE STUDIES – AJ ASSOCIATE DEGREE FOR TRANSFER (ADT) ROADMAP

This is a sample pathway for students who transfer to San Francisco State University in the current Bulletin year with an AS-T in Administration of Justice. Six units in the major (Electives) and all lower-division GE requirements have been satisfied. Check with a major advisor about the most appropriate course sequence. **Degree completion guaranteed in 60 units; see the Associate Degree for Transfer (ADT) section for more information (<http://bulletin.sfsu.edu/undergraduate-admissions/transfer-students/>).**

To Do at SF State:

Enough total units to reach 120 minimum for graduation; 30 units minimum at the upper-division level; to include the following:

University-Wide Requirements: 9-15 Units

- American Institutions (0–6 units): US History, US Government, California State and Local Government requirements if not taken before transfer.
- Upper-Division GE (9 units): Courses required for the major may double-count if approved for UD GE.
- Students entering the major with the AS-T in Administration of Justice are not required to fulfill SF State Studies requirements.
- Complementary Studies: Consult with a department advisor on how transfer units and/or SF State units can be applied to ensure degree completion within 60 units.

Criminal Justice Major: 30-34 Units

Six units from the AS-T can apply to Electives – see a department advisor.

- Core Courses (18 units)
- Electives (12-16 units)

University Electives: 18 or More Units

Depending on course choices made at the community college, how transferred units are applied to the requirements above, and course choices at SF State. Some courses may meet more than one requirement, e.g., in both UD GE and in the major. Upper-division electives recommended to meet the minimum 30-unit requirement.
